Last call for Cortland... This just in from the Conference organizers. The deadline is fast approaching and your 2012 Convention Committee is continuing to work hard. We have a jam packed week planned for all attendees. Please see the attached *tentative* schedule (page 5) for details.

Everyday starting on Monday and continuing through Thursday we will be having a wine tour that will leave the hotel on a 15 passenger van. The cost is \$40.00 per person. For that you will get your transportation, your lunch, all tasting fees (\$22), a coupon book worth \$14 for the wineries and a commemorative glass from Ithaca Brewery.

First ride of the convention will be on Tuesday to Corning. The ride will be run by Tom Boyle. He is planning on taking some nice roads from Cortland through Ithaca and Watkins Glen to Corning. Once there you will be parking in the blacktop parking lot at the Corning Glass Museum. You will be able to go through the Glass Museum or just mosey across the bridge into the town where you will find the Rockwell Museum of Western Art and several small shops prime for shopping.

Tuesday night we will be having an ice cream social at the A&W Root Beer stand in Cortland. It is a short 3.5 mile ride from the hotel. If you would like they also have a miniature golf course said to be the best in the area.

The second ride will be on Wednesday to Cooperstown. This ride will be led by Dean Gonya and Kent Dorney. They are taking you to Cooperstown on the country roads of Central NY State. Once there you will be parking in a gravel lot where you will be picked up by the city's trolley (no cost) which will take you into the city where you will be able to go to the Baseball Hall of Fame (tickets \$17.50 in advance - see registration form. If you are over 65 you will purchase your tickets when you get to the museum for \$10.75). You will be able to see Double Day Field and purchase a litany of baseball memorabilia in the town's several shops. Wednesday night we will have a pizza and wing party in the hotel ballroom followed by the Annual Meeting.

On Thursday morning Kent Dorney will be leading a short ride to Skaneateles, NY. This small town at the top of Skaneateles Lake is full of small shops or you can just hang out by lake. We are looking at the possibility of setting up a boat ride on the lake's tour boat. Thursday night will bring our Conference to an end with the banquet in the hotel ballroom.

Everyday starting on Monday at 4:00 PM the hospitality room will be open. There you will find the normal snacks, pop, water and information. We will be holding a basket draw, bug run contest, Farkle tournament and just a whole lot of fellowship. We are looking forward to seeing EVERYONE out this year, so get your reservations in by July 1.

Minutes of the May 19, 2012 Executive Board Meeting... The Spring 2012 meeting of the M.M.C.I. Executive Board was called to order by Vice-president Ron Ferraro at 4:00 PM in the conference room of the Ramada Inn in Cortland, NY. All elected and appointed officers were present except for Ken White, President; Dave Page, Two Year Trustee; Gordy Aune, Jr., Four Year Trustee; Cliff Wilson, Lifetime Trustee; and Doug Kelley, Lifetime Trustee. Chapters 1, 3, 8, 12, 25 and 32 were represented. Opening prayer was given by Jeff Killian, International Chaplain, and the Pledge of Allegiance was led by Ron Ferraro, Vice-president.

Minutes of the previous Executive Board meeting were approved.

Sickness and Distress: Cliff Wilson had surgery the previous week. Ken White's mother passed away in early May.

Officers Reports:

President: Ken left a written report for Ron to discuss under New Business.

Vice-president: As published in his VP's message.

Secretary: as published in the Secretary's report. Jeff reported that after many attempts, Chapters 15, 18, 28 and 47 still had not paid the previous year's dues. These Chapters were moved to inactive status, but can be reactivated should past and current dues be paid.

Treasurer: as published in the Treasurer's report.

Trustees: Nothing to report.

Committees: Bylaws: a discussion was held about amending the Constitution and Bylaws to accommodate the need for an Ohio address since the Club is incorporated in Ohio. Kent Dorney will assist the Bylaws Committee and draft language to be considered at the next Annual Meeting. Membership reported that since January 1, 2012, Chapters 49, 50 and 51 have been added, and 12 new Chapter 8 members have been enrolled. Quartermaster report as published. The 2012 Annual Conference Committee reported on scheduled activities, the Wednesday evening dinner and Annual Meeting, and the registration count as of May 19 (28).

Old Business: Purchase of Italian flag for display at Exec Board and Annual Meetings will move forward since Chapter 45's dues were received. Chapter 24 has offered to not only purchase, but to pay for and donate the flag to MMCI.

New Business: Ken requested in his report that a discussion be held about the creation of a Sunshine Committee. This idea was proposed by Connie Dorney (Kent's wife). In her proposal, Connie indicated that funds used to support the activities of the Sunshine Committee (sending get well cards and the like) would be raised by the committee at the Annual Conference through raffles or other fund raisers. It was agreed that this committee would be an ad hoc committee, and not a Standing Committee. As such, the President can appoint the committee and its members, and they will serve for that term. Each succeeding President will have the option to continue the committee. Ron reported that a location for the 2013 Annual Conference is still being sought. He mentioned Gettysburg, PA and Pigeon Forge, TN as possibilities. Concerns about the heavy traffic at Pigeon Forge were raised, as well as the cost of Gettysburg. Ron will look into Gettysburg. Dick Morse suggested that the Club return to Canaan Valley, WV. This was met with an enthusiastic response. Dick will provide the Exec Board with more info. Chapter 51 has requested permission to create a flag that they can use at events and meetings which incorporates the MMCI logo. A motion was made and seconded to approve this request. Passed.

A discussion was held regarding the use of the MMCI logo, how it can be worn, and who may wear it. Jeff proposed that this discussion be tabled until such time as the President appoints a committee to review the use of the logo as provided by the Constitution and Bylaws and past practice, and present a recommendation to the Exec Board for consideration and approval. Discussion tabled.

Next Executive Board meeting will be held at the Ramada Inn, Cortland, NY on Tuesday, August 14, 2012. Time and room to be announced.

The closing prayer was given by Jeff Killian. Motion to adjourn moved and seconded. Passed. Meeting adjourned at 5:25 P.M.

Proposed Changes to the Constitution and Bylaws... The following proposed amendments to the M.M.C.I. Constitution and Bylaws will be presented for approval at the Annual Meeting to be held on Wednesday, August 15, 2012 at the Ramada Inn in Cortland, NY. Only Members who are in good standing will be able to cast a vote to support or reject the proposed amendments. The proposed amendments have been submitted to and approved by the M.M.C.I. Executive Board for consideration at the next Annual Meeting of the M.M.C.I.

The first proposed amendment clarifies the eligibility of a Member-at-Large (Chapter 8) to serve as an elected officer of M.M.C.I..

ARTICLE IV - OFFICERS

The elected Officers of the M.M.C.I. shall be, President, Vice President, Secretary, Treasurer, 2 year Trustee, 4 year Trustee, 6 year Trustee. The President, Vice President, Secretary, Treasurer and 6 year Trustee will be elected for two one year terms. (Odd Years.) The Officers must be elected by a majority vote and must have served as an elected Officer of a subordinate Chapter. Members-at-Large may serve as an elected Officer of M.M.C.I. if they have attended at least two Annual Meetings and served two one year terms on a standing or created committee of the M.M.C.I.

Proposed Change to (changes are in bold and italicized):

ARTICLE IV - OFFICERS

The elected Officers of the M.M.C.I. shall be, President, Vice President, Secretary, Treasurer, 2 year Trustee, 4 year Trustee, 6 year Trustee. The President, Vice President, Secretary, Treasurer and 6 year Trustee will be elected for two one year terms. (Odd Years.) The Officers must be elected by a majority vote and must have served as an elected Officer of a subordinate Chapter. Members-at-Large may serve as an elected Officer of M.M.C.I. if they have attended at least two Annual Meetings ***and/or served two (consecutive)*** one year terms on a standing or created committee of the M.M.C.I.

The second proposed amendment addresses the need for M.M.C.I. to maintain a Club address in the State of Ohio because that is where the Club is incorporated. In addition to changing the wording of one article of the Constitution, the proposed amendment adds another article to the Constitution.

ARTICLE III – MEMBERSHIP

Membership in this organization requires that members must be a Master Mason in good standing, a member in good standing of a subordinate Chapter of the M.M.C.I. and a member in good standing of the M.M.C.I. (** Hereafter referred to as **Active Member**). Chapters may adopt Social Members (Spouses,) to their By-Laws at their discretion.

** Since the M.M.C.I. was founded & Incorporated in the State of Ohio and underwritten by the Grand Lodge of Ohio, Active Member's State or attending Lodges must be recognized by the Grand Lodge of Ohio located in Worthington, Ohio. Incorporation # 669745. Ohio is the home State of The Masonic Motorcycle Club @ International Inc. The home address shall be: 1567 Kinsman Rd. N. E. North Bloomfield, Ohio. 44450. % Rex Baker

Changed to read:

Article III – Membership

Members of this organization must be a Master Mason in good standing, a member in good standing of a subordinate Chapter of the M.M.C.I. and a member in good standing of the M.M.C.I. Hereafter referred to as **Active Member**.

Since the M.M.C.I. was founded & Incorporated in the State of Ohio and underwritten by the Grand Lodge of Ohio, Active Member's Grand Lodge and attending Lodges must be recognized by the Grand Lodge of Ohio, located in Worthington, Ohio. Incorporation # 669745.

Chapters may adopt Social Members (Spouses,) to their By-Laws at their discretion.

Add to Constitution:

Article IX – Organization Address

M.M.C.I. was founded and Incorporated in the State of Ohio and underwritten by the Grand Lodge of Ohio. Therefore, the State of Ohio, United States of America, is the home location, and shall remain the home location, of The Masonic Motorcycle Club @ International Inc.

To preserve M.M.C.I.'s home location the organization's official and mailing address shall be maintained as follows:

1. If the International Secretary is a resident of the State of Ohio, then his address shall be deemed the official and mailing address for M.M.C.I.
2. In the case where the International Secretary is not a resident of the State of Ohio, an Active Member of the Club, who is a resident of the State of Ohio and is agreeable to having their address utilized as the Club's official and mailing address shall be approved by a majority vote of the International Board of Directors.
 - a. The Active Member maintaining the Club's official and mailing address shall timely transfer all communication to the Board of Directors, or other appropriate officers or Committee Chairman as directed by the Executive Board.
