Minutes of the November 3, 2012 Executive Board Meeting... The Fall 2012 meeting of the M.M.C.I. Executive Board was called to order by President Ken White at 4:00 PM in the conference room of the Quality Inn in Apalachin, NY. All elected and appointed officers were present except for Dave Page, Two Year Trustee; Jeff Killian, Chaplain; and Cliff Wilson, Lifetime Trustee. Chapters 1, 8, 12, 14, 24 and 32 were represented. Opening prayer and the Pledge of Allegiance were led by Ken White, President.

Minutes of the 2012 Annual Meeting were approved as written.

Sickness and Distress: It was reported that Charlotte VanKirk, wife of Member John VanKirk, had surgery and was recovering.

Officers Reports:

President: Nothing to report.

Vice-president: Ron gave an update about the 2013 Annual Conference in Canaan Valley, WV.

Secretary: as published in the Secretary's report.

Treasurer: as published in the Treasurer's report. A brief discussion was held regarding the use of the Chapter 8 PayPal account to receive dues from Chapters located outside of the U.S. George requested that he be authorized to purchase a new printer for use with the club laptop he has. A motion was made, seconded and approved to authorize George to spend up to \$200 for a new printer.

Trustees: Nothing to report.

Committees: The Safety Committee discussed the increased prevalence of trikes among motorcyclists today, and stated that the accepted group riding procedure for mixed vehicle groups is two wheels, then three wheels, then four wheels. There was a short discussion about the Nominations Committee and potential candidates for the upcoming election in August. The Audit Committee stated that as of the Annual Meeting, the books were in satisfactory shape. The Audit Committee will submit a written report to that effect. Membership submitted a written report. Website reported minimal interest in setting up a sunshine page on the site. Doug also requested that payment for the site be shifted to the Treasurer. Quartermaster report as published. The 2013 Annual Conference Committee reported that contracts had been signed with Canaan Valley Resort, and that the agenda had been firmed up and the registration form would be sent to the Secretary for publication in the next newsletter.

Old Business: The discussion continued about the creation of an Annual Conference handbook. After the handbook is completed, it will be available to any Chapter or Member who is considering submitting a proposal to host an Annual Conference. It was agreed that the Constitution and Bylaws, and the Conference Handbook will be available on the MMCI website, but those documents will be available only to registered Members.

New Business: A discussion about the approval process for local Chapters who wish to develop logos based on the MMCI logo was held. As stated in the Bylaws, a Chapter must receive approval from the MMCI International Executive Board before a logo may be produced. George said that he would draft a resolution addressing who may or may not wear patches which incorporate the MMCI logo. Specific to the 2014 Annual Conference to be held in Gettysburg, PA, the question of whether to hold it on Tuesday through Friday versus

Wednesday through Saturday was addressed. It was agreed that Tuesday through Friday is the preferable schedule. A request has been received from Chapter 49 to host the 2015 Annual Conference in Wisconsin. Before any decision will be made, Chapter 49 needs to submit a formal proposal before their request can be considered by the Executive Board.

Good of the Order: Nothing to report.

Next Executive Board meeting will be held at the Ramada Inn, Cortland, NY on Saturday, April 6, 2013. Kent will make the arrangements.

The closing prayer was given by Ken White. Motion to adjourn moved and seconded. Passed. Meeting adjourned at 5:20 P.M.
